

## **SPEAKER BIOS**

<u>JUDGE RACHELLE ANDERSON</u> was appointed to Superior Court Dept. 12 in January 2019, prior to that, she served as a Spokane County Superior Court Commissioner since December 2010. Judge Anderson spent 14 years in private practice, focusing on family law and juvenile dependency matters. She spent a brief time as an Administrative Law Judge with the Washington State Office of Administrative hearings before her time on the bench.

Professional Affiliations: Judge Anderson currently serves as Co-Chair of the Superior Court Judges' Association's Legislative Committee. She is a past President of the Superior Court Judges' Association, (2021-2022). She serves on the SCJA Guardianship and Probate Committee, which she formerly chaired. She is former Chair of the Certified Professional Guardianship Board, former Chair of the WSBA Character and Fitness Board, and former Washington Young Lawyer Division Trustee.

<u>RAYMOND A. CEBULA</u> is a member of the Extension Faculty of Cornell University's Yang-Tan Institute on Employment and Disability. As a faculty member, he provides technical assistance and training to Protection and Advocacy program attorneys and paralegals in 16 states and territories covered by Cornell's Work Incentive Support Center.

As an experienced social security disability attorney Mr. Cebula practiced with the Disability Benefits Project as a Senior Staff Attorney with the Disability Law Center in Boston, Massachusetts. He has also served as a Managing Attorney of the Disability and Medicare projects at Southeastern Massachusetts Legal Assistance Corporation. He is a graduate of Franklin Pierce Law Center in Concord, NH and received a Reginald Heber Smith Community Lawyer Fellowship upon graduation. He is also a graduate of Merrimack College and holds a Bachelor of Arts degree in history. His practice has concentrated in the area of social security practice and has brought several pieces of significant litigation on behalf of low income, disabled social security beneficiaries. While working with the Disability Law Center, Mr. Cebula taught at Harvard Law School's Legal Aid Bureau for a period of three academic years.

He is the co-author of the MCLE publication An Advocate's Guide to Surviving the SSI System, as well as several SSI practice manuals published by Massachusetts Continuing Legal Education, and is a regular presenter of social security related programs at local and national conferences of social security practitioners.

<u>FRANK CHRISTOFF</u> graduated from Gonzaga University School of Law in 1990. He served as a Spokane County Prosecutor from April 1991 to September 2017. He spent approximately 19 years prosecuting Juvenile Offenses. After retiring from the Prosecutor's Office, Mr. Christoff served as a Judge Pro Tem, largely doing the Spokane Valley Infraction Docket, handling Children in Need of Services case in Juvenile and working as a Guardian ad Litem. This is his third-year handling GAL cases.

<u>CATHERINE KARDONG</u> - Catherine graduated first in her class from Gonzaga University School of Law and began her legal career at the Washington State Supreme Court, where she clerked for Washington Supreme Court Justice Mary E. Fairhurst. She was then selected as an honors candidate at the Washington State Attorney General's Office and spent two years in Olympia representing areas within the Department of Social and Health Services that serve the aging and disabled populations of Washington. Catherine and her family relocated to Spokane where she continued on with the Attorney General's Office and began representing various institutions of higher education, most recently acting as lead counsel for Eastern Washington University.

Catherine is originally from Spokane, having graduated from Lewis and Clark High School before venturing to the east coast to earn her undergraduate degree from Boston College. During law school, she was a Thomas More Scholar and a member of the Gonzaga Law Review. She also clerked for United States District Court Judge Robert H. Whaley and United States Bankruptcy Judge John A. Rossmeissl. She was admitted into practice in Washington in January of 2014.

She is the author of, But I Didn't Say Goodbye: Helping Families After a Suicide (3ed). Barbara co-authored the Department of Justice, Office for Victims of Crime Training Curriculum, Compassion Fatigue.
