<u>ADAM PAPINI</u> - For over 20 years I dedicated my professional life to serving the citizens of Spokane as an assistant Public Defender and Prosecuting Attorney. My career took many forms over my tenure with the City. My greatest achievements have been in my role as the co-creator/founder of the Spokane Community Court and the Senior Prosecutor in the Domestic Violence Unit. In the course of working for the City of Spokane, I worked hand in hand with Code Enforcement officers in addressing nuisance properties and developing creative ways to abate the nuisance or prosecute the individual for failing to abate.

In 2013, I co-founded the Spokane Municipal Community Court, which is a problem-solving court created to address homelessness and quality of life crimes. I developed a multi-level response to chronic homelessness by forming partnerships with law enforcement / first responders, governmental agencies, academics, the medical community, service providers and local non-profits.

In 2020 I left the city of Spokane to aid victims of domestic violence by partnering with the YWCA and private family law attorneys, along with forming my private practice. I then shifted to non-profit work, assisting tenants with landlord disputes and defending against evictions. My career has now evolved into private practice, which currently consists of representing landlords, local municipalities, and individuals accused of crimes. My approach to the law is to see both sides, resolve issues when possible, and litigate conflicts that do not reach a mediated resolution.

<u>SANDRA SCHILLING</u> is a Professional Responsibility Counsel in the Advancement department of the Washington State Bar Association. As Professional Responsibility Counsel, Sandra serves as an advisor to members of the bar on the Rules of Professional Conduct, and staffs the Committee on Professional Ethics. The favorite part of her position is one-to-one contact when members call her for Ethics Line assistance. She contributes regularly to Bar publications, especially posting regarding new Advisory Opinions or other emerging ethics issues.
